5. Fire-fighting measures

Extinguishing media

Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapors. Evacuate area. Methods for cleaning up Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely.
